## LSR Members Receive Presidential Award from President Obama

LSR Program Chair Patty Dean is one of three Salisbury University education professors to receive the President's Gold Volunteer Service Award this spring. Drs. **Patricia Dean**, **Ernie Bond**, and **Laura Marasco** (all of whom have presented at previous LSR Roundtables) were honored for their more than 500 hours of volunteer service on behalf of the Green Earth Book Awards. The Green Earth Book Award was established by the Newton Marasco Foundation, a Virginiabased environmental charity, and is the nation's first award to recognize environmental stewardship in children's and young adult literature.

The official citation, signed by President Barack Obama, read in part: "Thank you for helping to address the most pressing needs in your community and our country. ... Your volunteer service demonstrated the kind of commitment to your community that moves America a step closer to its great promise."

Congratulations to Patty, Ernie, and Laura, and thank you for your outstanding service. Your dedication inspires all of us.
